

## Wind orchestra conducting course's regulation

### Art. 1 - Qualifications

This programme of study is addressed to musicians, conductors, teachers, Conservatoire's or other kinds of music school pupils' who aim to develop and/or enhance technical and cultural literacies related to wind orchestra conducting. Specific diplomas or degrees are not required.

### Art. 2 - The course

The whole course lasts 3 years, 60 hours of classes each year.

This year the activities will take place from October 2017 until June 2018 scheduled one weekend per month. Classes will be held on Saturdays and Sundays 6 hours a day and the timetable will be arranged directly between the attendees and the teacher.

### Art. 3 - Enrollment methods

The registration is annual and *does not oblige to register for the following years* of the programme. The applicant needs to fill in the registration form (which can be downloaded from our website [www.orchestradi-fiati.com](http://www.orchestradi-fiati.com) ) and send it via e-mail to [segreteria@orchestradi-fiati.com](mailto:segreteria@orchestradi-fiati.com) along the receipt of payment.

### Art. 4 - Registration fee

The annual cost is:

- € 550,00 for the 1st year of attendance. The sum can be divided in two instalments of:
  - € 300,00 at the time of signing up
  - € 250,00 by February 2018

Optionally, the applicant can invest:

- € 270,00 to attend one of the classes provided by ISEB's teachers
- € 65,00 to spend an entire day attending a class chosen among ISEB's tuitions
- € 1050,00 to attend the whole ISEB course

The overall fee will be deposited through bank transfer to *Associazione Orchestra di Fiati della Provincia di Vicenza* at Banca Popolare di Verona.

The fee will be entirely refunded in case the course will not take place due to lack of the minimum number of enrollments.

#### Art. 5 - Transportation, board and lodging

Attendees are in charge of their own transportation, board and lodging expense. However, the Association *Orchestra di Fiati della Provincia di Vicenza* will assist attendees providing them a list of under agreement local hotel facilities and restaurants.

We recommend whoever is inclined to benefit from this service to inform us about it *as soon as possible* in order to make reservations.
